Applicants should hold recognised professional or industry qualifications appropriate to their profession.

## How is the course delivered?

The course will be held on a hybrid mode with both face-to-face and virtual setting.

# How will I be assessed?

The Introduction course will include an online assessment process if participants wish to qualify for Associate membership status of the Chartered Institute of Arbitrators. Details of the online assessment procedure are set out below. When taking the online assessment, in brief, this is what you can expect:

- An assessment comprising 60 multiple choice questions
- The questions are derived from the content of the course workbook
- You will be given log-in and password details to access the assessment
- You will find instructions as to how to work through the assessment when you log in
- There will be a short, practice test for you to experiment with before you start the assessment proper
- Once you log onto the assessment, your access to it will be open for 28 days
- You will have up to three attempts to take and pass the assessment
- Your result will be displayed immediately on completion of the assessment
- On passing the assessment, you will be invited to print your own certificate
- You will then have the opportunity to apply for ACIArb Membership and to consider proceeding along one of the training and qualification pathways
