IN **INTERNATIONAL ARBITRATION**
(Entry Level Course)

COURSE OBJECTIVE

This introductory course covers the fundamental concepts of international arbitration and its interconnections with different approaches of dispute resolution. Participants will receive an introductory overview of the legal framework, as well as best practices and procedures pertaining to international arbitration.

LEARNING OUTCOMES

Participants who have completed this course will possess the following outcomes:

- Comprehend the background of international arbitration;
- Capable to describe the process and procedure of international arbitration;
- Understand the concept of international arbitration in relation to other forms of dispute resolution.

THE SYLLABUS

- Comparison of dispute resolution procedures;
- Fundamental principles of the international arbitration process;
- The UNCITRAL Model Law and Arbitration Rules;
- Arbitration rules: institutional and ad hoc agreements;
- Arbitration procedures: documents only and oral hearings (live or virtual);
- The legal framework: the importance of the seat, the New York Convention, procedural laws, and procedural rules;
- The arbitration agreement;
- Commencement of the arbitration;
- An arbitrator's jurisdiction and powers;
- The arbitration process: obligations of the tribunal, responsibilities and obligations of the parties;
- Managing the arbitration process: communications, preliminary meeting, interlocutory matters, dealing with factual and opinion evidence and disclosure of documents including introduction to the IBA Guidelines;
- Presenting the claim and the defence: alternative methods;
- Procedure at a typical hearing, including contrasting common and civil law jurisdictions; Costs and interest: alternative approaches in different jurisdictions;
- Essentials of an enforceable award.

COURSE ASSESSMENT

Participants are required to complete the online multiple-choice examination. After receiving login credentials for the online platform, candidates will be granted a 28-day period to finish the assessment. During that time, they will be permitted three attempts to complete the task. The questions will be constructed in accordance with the material covered in the CIArb Introduction to International Arbitration course workbook. The course charge encompasses the assessment cost.

ENTRY REQUIREMENTS

There are **no prerequisites for admittance**. The course is intended for those who:

- are new to the field of international arbitration;
- wish to learn more about international arbitration and its benefits to users;
- aspire to obtain Associate membership in CIArb.

English Language Competence - Assessment and training for CIArb are conducted in English. Thus, written and spoken English proficiency are both essential requirements in prospective participants. It is advisable for candidates whose native language is not English to possess a minimum proficiency level equivalent to level 7 on the International English Language Testing System (IELTS) or a score between 94 and 101 on the Test of English as a Foreign Language (TOEFL) system. This recommendation is provided by CIArb as a guideline; however, candidates inadequate this level of English proficiency may be disadvantaged, although no proof of competency is required prior to course enrollment.

For the purpose of course registration, we shall need the submission of the following documents:

- A scanned document of **valid ID Card** (KTP or equivalent);
- A scanned document of **valid membership card** (if AAI Member);
- The latest **Curriculum Vitae**;
- A scanned documents of **transfer receipt for course fee**.

COURSE FEE

IDR 10,000,000 is the standard course fee. Course enrolment, course materials, online examination as well as lunch and coffee break during course are all included in the fees.
