The following fees for Peer Interviews apply to the country in which the interview is held, with fees for European Union countries being subject to VAT (marked \* – also see note # below). The fee for peer interviews held by Skype, are based on a candidate's primary country of residence as shown on your membership record.

The appropriate fee should accompany your application. When your application has been reviewed and it has been confirmed that you are eligible to attend a Peer Interview for Fellowship, the Member Services Team will contact you regarding interview arrangements, date, location and venue.
